Young people's willingness, aptitude, and chance to participate in the development of Muara Badak Ulu Village are three characteristics that are starting to become apparent.

1. INTRODUCTION

Contributions of ideas, contributions of materials, and contributions of aid are the three types of contributions that make up the form of participation. It is influenced and driven by the variables of willingness, capability, and opportunity, respectively.

CONCLUSION

Based on the findings and discussion, it can be said that using structural-functional theory, this research demonstrates that young people participated in village development in the form of repairing the Rt. 14 bridge, building road dividers, and fumigating the village of Muara Badak Ulu.
